Goal of the subject The main goal of the course is to study population migrations, as well as their consequences on demographic, socio-economic and cultural development.		
Outcome of the subject Understanding migration and demographic phenomena and processes that occur as a result of migration. Enabling students to recognize migration problems, use statistics and make studies on migration.		
Content of the subject <i>Theoretical lectures:</i> In International layout, human migration are defined as spatial flows between two geographical areas. This definition refers only to premanent change in place of living. In Serbia, under human migration are recognized each change in place of living (daily, seasonal, temporary or permanent). In this term, this course is dealing with: Definition and types of migration; Pull and push fators of migration; Gravity and econometric models; Rural-urban migration and urbanization. Migration by gender, age, marriage, education. Measurement of migration: net migration rate and migration balance. Transmigration from Europe. Settlement of US, Latin America, Australia and Siberia. Contemporary international migration. Refugee flows: definition, chronology, solutions. Consequences of migration (demographic, socio-economic and cultural). <i>Practical lectures:</i> To deliver essay with the topic addressing some of the issues and challenges of contemporary migration flows. Using the survey or quantitative and qualitative analysis of data, essay should contain original research results.
