Course Aims: The student needs to gain an understanding of the meaning, scope, and significance of comparing literary texts from different cultures, as well as develop a critical approach and awareness of relevant theoretical and historical contexts for examining literary facts.

Learning Outcomes:

The student has acquired the terminology of comparative literature and culture, gained knowledge about the basic methodologies of studying literature and culture from positivism to the present day. Syllabus:

Theory

Throughout the course, students will familiarize themselves with the methods and techniques necessary for the comparative study of literature, ranging from an introduction to the scope and history of the concept of comparative literature to the examination of literary themes, literary mediation, translation, influences, intertextuality, quotationality, mutual illumination of the arts, imagology, narratology, genology, interdisciplinarity, and analysis of various methodologies from the perspective of comparative studies of literature and culture (positivism, Geistesgeschichte, Russian Formalism, New Criticism, reception theory, psychoanalytic and archetypal criticism, structuralism and semiotics, poststructuralism, cultural studies, new historicism).

Practice:

Working with specific theoretical texts mentioned in the literature. Exploring different approaches to comparative literature studies, with particular emphasis on the potentials of specific approaches. Special attention will be given to developing an understanding of the relationship between Serbian and other literatures, as well as acquiring basic techniques of scholarly work."
