Vocal Counterpoint: Methods of working on two-part and three-legged polyphony; Instrumental Counterpoint: methods of making of two-part and multi-part setting; Musical Form. Goals and tasks of teaching Musical Form. Review and analysis of the curriculum for the subjects Music Form 1, 2, 3;			
<i>Summer semester:</i>			
Music theory: processing and determining scales, intervals, chords. Harmony: harmonization of the given soprano, the given bass and the encoded bass (diatonic, alterations as figurative and as chord sounds, extended tonality, diatonic, chromatic and enharmonic modulations); Counterpoint: Vocal Counterpoint (imitation, vocal treatment, vocal polyphonic forms) and Instrumental Counterpoint (invention, fugue, instrumental polyphonic forms).
